*** SHERIFF SERVICE OF PROCESS FEE 28.00***

The Clerk shall collect this fee from a party requesting service of a writ, an order, a process, a notice, a tax warrant, or any other paper completed by the Sheriff.

The Clerk shall collect a service of process fee of \$28.00. (This is an increase of the current \$25.00 fee). A service process fee may only be collected one time per case for the duration of the case. The Clerk may collect an additional service of process fee of \$28.00 per case for any post-judgement service.

The Clerk shall collect from the person the person who filed the civil action a service of process fee of \$60.00 for any civil action outside of Indiana and the sheriff is requested to perform a service of process associated with that case.
