IN THE MATTER OF APPROVAL OF ORDINANCE NO. 2010-BC-O-12, ORDINANCE ESTABLISHING A FOUR (4) WAY STOP INTERSECTION

County Engineer, Chuck Leser, reported to the Commissioners that the intersection at CR 200 S & CR 400 W, aka 38th Street and Layton Road, has been investigated by State law set guidelines to see if the crossing qualifies for a 4-way stop. It has been determined that it does qualify for the 4-way stop signs. There is now a "Cross Traffic Does Not Stop" sign in place. Motion was made by Paul Wilson and seconded by John Richwine to approve said Ordinance 2010-BC-O-12. Motion carried.

ORDINANCE 2010-BC-O-12

ORDINANCE ESTABLISHING A FOUR (4) WAY STOP INTERSECTION

WHEREAS, the Board of Commissioners of Madison County, Indiana has determined it to be in the best interest and safety of Madison County and the citizens thereof for the establishment of a four (4) way stop intersection at the intersection of County Road 200 South (38th Street) and County Road 400 West (Layton Road), Madison County, Indiana.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MADISON COUNTY, INDIANA:

Section 1. That the intersection of County Road 200 South (38th Street) and County Road 400 West (Layton Road), Madison County, Indiana, be and is hereby established and designated as a four (4) way stop intersection.

Section 2. That this ordinance be in full force and is effect from and after its passage and legal publication.
