- ◆ Aluminum Beverage Cans & Aluminum Food Cans (empty & rinsed clean)
- ◆ Tin & Steel Cans- Soup, Coffee, Fruit & Vegetable Cans (empty & rinsed clean)
- ◆ Clear Glass, Brown Glass, Green Glass (empty & rinsed clean, no lids or metal rings, **no window or plate glass, drinking glasses or vases**) Blue glass & any other than listed colors not accepted at this facility.
- ◆ **ALL PLASTICS MUST BE FOOD OR BEVERAGE CONTAINERS ONLY**
- ◆ Number 1 Plastic (empty & rinsed clean, no lids or caps)
- ◆ Number 2 Plastic (empty & rinsed clean, no lids or caps, no oil containers, **no plastic bags**)
- ◆ Number 3-7 Plastics (empty & rinsed clean, no lids or caps, **no styrofoam, no plastic bags**)

ALL FEES, CASH ONLY

ELECTRONICS

No charge items: microwave, radio, telephone, speaker, calculator, keyboard, computer mouse, VCR, computer, CPU, laptop, camera, stereo, ink jet printer

\$2.00 items: computer monitor smaller than 20", TV smaller than 20", laser printer

\$5.00 items: computer monitor larger than 19", TV larger than 19", desktop copier

\$10.00 items: console TV, loose picture tubes, projection TV, mainframe, floor-standing copier

NOTE: Other items of similar size & weight in each category may be accepted.

HOUSEHOLD HAZARDOUS WASTE

ACCEPTABLE PRODUCTS

- ◆ Oil-Base Paints, Stains & Related Items (remove lids on **empty** cans and place in regular trash removal)

Please note: 15 gallon limit (by container size) per household, per year. Volumes over 15 gallons shall be charged one dollar per gallon. Volumes less than one gallon over the 15 gallon limit shall be charged the one gallon rate.)

- ◆ Household Cleaners and Lawn and Garden Chemicals
- ◆ Automotive Fluids (drums, please call ahead.)
- ◆ Batteries (lithium, rechargeable, lead acid) Please discard alkaline batteries in your trash.
- ◆ Fluorescent Light Bulbs
- ◆ Aerosol Cans
- ◆ Pesticides, Herbicides and similar lawn chemicals

Car & light truck tires - \$1.00
Semi tires & other large tires - \$5.00
Tractor tires - \$15.00
Tires on rims charged double.

Tires must be free of dirt, mud, & rocks.
